GENERAL CONDITIONS OF PARTICIPATION

I. APPLICATION, CONCLUSION OF CONTRACT

- 1/ Exhibitors submit their application on the Application Form of the HORTUS HUNGARICUS Exhibition . Exhibitors are required to return the Application Form carefully filled in and properly signed before the allotted deadline to the address of Flora Hungaria Ltd. The returned and properly signed Application Form is considered as an order and acceptance of the conditions of participation.
- 2/ The Exhibitor is requested to indicate the data of his co-exhibitor partner/s/ who wish/es/ to participate in the Exhibitor's stand. The co-exhibitor is also bound by the rules accepted by the Exhibitor, however financially only the Exhibitor is liable. Except the indicated co-exhibitors, other companies can not be represented, neither by their exhibits / products/ or by any kind of information material.
- 3/ The Exhibitors are informed on the acceptance of their application by the confirmation of Flora Hungaria Ltd. and the invoice for the space fee will be issued. Doing so the contract between the Exhibitor and Flora Hungaria Ltd. is regarded as concluded.
- 4/ Flora Hungaria Ltd. has all right allocate the exhibition space without explanation. The space claims will be confirmed and accepted in the order of incoming applications.
- 5./ The allocation of the exhibition spaces will be done in the middle of July 2011. Only the applicants with settled space fee will gain allocation.
- 6/ The exhibition space allocated by Flora Hungaria may not be changed by the Exhibitor with any other exhibitor, may not be enlarged or should not be sublet without the prior written consent of Flora Hungaria Ltd.
- 7/ The Exhibitors are entitled to display exhibits and services listed on the application form, and confirmed by Flora Hungaria Ltd.
- 8/ All Exhibitors having applied before the deadline are entitled to take part in the online and printed official catalogue. The registration's fee, compulsory paid by all exhibitors, includes the basic catalogue entry.
- 9/ Selling of any kind of products for the visitors is permitted only under the conditions of the valid tax regulations.
- 10./ Selling is only permitted at the indoor Market Hall and outdoor area.

II. TERMS OF PAYMENT

- 1/ The space rental fee is payable according to the conditions written in the Pro forma Invoice of Flora Hungaria Ltd. sent as an acceptance of the application. Following the payment an advance payment invoice will be issued. After closing the exhibition will be issued the final invoice. Registration fee Euro 60,00 + VAT/company will be invoiced with the space rental fee. The application fee of the Product Competition must be paid in advance.
- 2/ In no circumstances will the Exhibitor be permitted to occupy his exhibition space, to begin construction or decoration of his stand, if the space rental fee has not been paid in full.
- 3/ All costs of on site and other services will have to be paid according to the orders and agreements of the Exhibitors and Flora Hungaria Ltd.

III. WITHDRAWAL, CLAIMS, LEGAL DISPUTES, INTEGRAL PARTS OF THE CONTRACT

- 1/ If the Exhibitor withdraws his application prior one month of opening of the exhibition, Flora Hungaria Ltd. has the right to forfeit 50% of the rental fee. In case the Exhibitor withdraws his application within one month before the opening of the exhibition, he is subject to pay 100% of the rental fee.
- 2/ In case the Exhibitor does not occupy his allocated space 24 hours prior to the opening of the show, Flora Hungaria Ltd. has the right to re-rent the space to any other exhibitor without any obligation for compensation or refund. If the Exhibitor misses to be present at all 100% of the rental fee and the ordered and executed services, are charged.
- 3/ The Exhibitor has to submit his claims in writing to Flora Hungaria Ltd. regarding the organisation, execution, operation before the end of the show in order to be able to prove his claims. Claims concerning invoices shall be submitted within the deadline for payment. Claims received after the given deadlines cannot be considered.
- 4/ In case of causing damage or loss by the Exhibitor due to his guiltiness or contributory negligence, compensation must be paid or effected according to the rules of the Hungarian Civil Law.
- 5/ The contracting Parties agree that the laws of Hungary shall be applicable to this agreement.
- 6/ The rules of this *General Conditions of Participation* will be completed with the *General Rules and Regulation of Exhibiting and Operation*, what will be sent with the space fee pro forma invoice. The *Rules of Prize and Competition* will be issued separately.

The undersigned acknowledges the provisions of the conditions of participations as well as that of the application form as binding.
